

## ACCEPTABLE CATEGORIES

Acceptable categories will include original works by the artist, limited editions in 2 and 3 dimensional arts, and fine crafts:

- Pottery/Clay
- Furniture
- Drawing/Pastel/Graphics
- Basketry
- Fiber/Weaving/Textiles
- Wood
- Glass
- Watercolor
- Oils/Acrylic/Mixed Media
- Paper
- Sculpture
- Printmaking
- Leather
- Photography
- Jewelry
- Metal

All work must be original by exhibiting artist. No unlimited prints or hobby kits are allowed.

Kits, imported items, commercial exhibits, candles, mass-produced items, mold ceramics, shells, decoupage, crocheting, artificial flowers, etc. are ineligible.

Festival committee reserves the right to prohibit display of work not representative of that which was juried. Slides/photos will be returned to the artist after review of display by the committee on the festival weekend.

## ENTRY TO THE FESTIVAL

- Complete entry form attached. Application deadline is 3-01-11.
- Submit 3 properly labeled 35mm slides or 4 x 6 photos of your work (up close) to be exhibited and one slide/photo of booth display.
- Include the non-refundable application fee of \$25 by check payable to Canton Festival of the Arts.
- Include separate \$100.00 booth fee (\$125.00 for access to electricity) by check payable to Canton Festival of the Arts with a stamped, self-addressed business size envelope.
- The check for the booth fee will be deposited immediately after jurying. Checks for artists not accepted will be returned with jury notification. A \$25 charge will apply for returned checks.

- Notification to accepted artists will begin 3-15-11.
- We regret that no refunds will be made once an artist is accepted.
- Only one artist may exhibit per space. Artists (no agents, dealers or representatives) must be present and remain through the 2-day event.
- No commission will be charged on your sales. Artists must handle sales tax according to their individual status. Current sales tax is 6% (5% Georgia State and a 1% local option sales tax.)

## SET-UP AND SECURITY

- Set-up may begin at 12 pm on Friday, May 20, or at 6:30 am on Saturday, May 21. Set-up details, maps and motel information will be mailed in advance of the festival.
- Artists must provide all display equipment and tents.
- Artists are responsible for securing their tents against acts of nature. Electricity is available on a limited basis and will be assigned on a first-come, first-served basis. An additional fee of \$25.00 will be charged for booths with access to electricity. Booth space will be **12' x 12'** to accommodate a 10' x 10' tent.

- Security will be on duty Friday and Saturday nights. The Arts Center assumes no responsibility for lost or stolen items, however, every precaution will be taken to secure your property.

## HOSPITALITY

- Our committee will serve complimentary coffee and light breakfast items both Saturday and Sunday mornings.
- Every effort will be made to provide convenient parking and restroom facilities for artists.
- A reception will be held for our artists on Saturday evening.
- Volunteers will be available to assist with set-up, breakdown and as booth sitters during the festival.
